Seaford Cricket Club take the protection of the data we hold about you as a member seriously and are committed to respecting your privacy. This notice is to explain how we may use personal information we collect and how we comply with the law on data protection, what your rights are.

Who we will disclose your personal data to	<ul> <li>Leagues (Sussex Cricket League)</li> <li>The England &amp; Wales Cricket Board</li> <li>Sussex Cricket Foundation</li> <li>Coaches and other volunteers for administrating training sessions &amp; matches.</li> <li>Volunteers who work at cricket clubs/venues to support the delivery of sessions.</li> <li>Third Party platforms we use to help collect and store your data i.e. The Rocket Science Group LLC (MailChimp) and Google.</li> </ul>
Legal basis for processing your personal data	<ul> <li>The legal basis for the collection and processing of your personal data is:</li> <li>For administration and programme delivery: that it is necessary to fulfil the contract that you are going to enter into or have entered into with us</li> <li>For dealing with medical needs: that you have given your explicit consent or in your vital interests.</li> <li>In all other cases: that it is necessary for our legitimate interests which are to build a programme to encourage participation in cricket and does not prejudice or harm your rights and freedoms.</li> </ul>
Your right to withdraw consent	Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.
Location of your personal data	'The Club' will keep your personal data within the European Economic Area wherever possible. However your data may be transferred to, stored, or processed in the United States in line with the Privacy Policies of The Rocket Science Group LLC (MailChimp) and Google. The Third Party platforms we use to help collect and store your data.
How long we will keep your personal data for	We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with <b>Seaford Cricket Club</b> as a member. <b>2 years</b> after you cease to be a member of 'the club' or play an active part in 'the club', we shall delete your data.
Your rights in respect of your personal data	You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.
